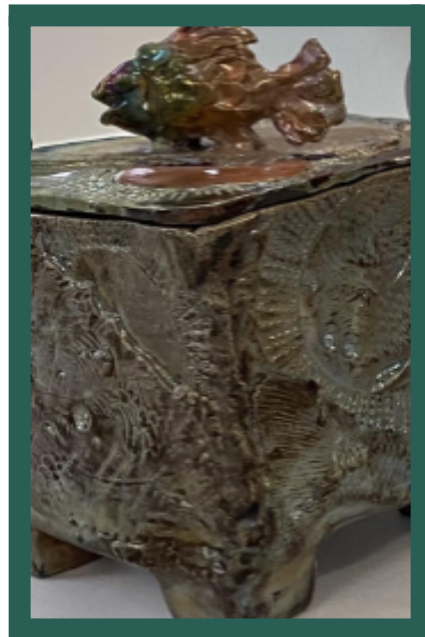

The SBPC Bowl and Vessel Show is a judged event encompassing three-dimensional art mediums in the form of bowls or vessels regardless of their food-safe nature. This show is open to all North Carolina- based artists. SBPC Membership is not required.

ENTRY FEE

\$35 per artist – limit 5 vessels per artist.

CONDITIONS OF ENTRY:

- All artworks must be original fine art quality conceived and created solely by the entering artist(s).
- All artworks must be appropriate for a family audience.
- Maximum dimensions: 3 feet height, 2 feet width, free-standing or able to display on a shelf or pedestal.
- All mediums are accepted. Vessels are not required to be food-safe but those that are must be labeled as such.
- SBPC will handle all sales from the exhibition and retain a 20% commission from all sales.
- All artwork must remain on-display through October 18 regardless of sale status.
- All Artists will be required to register on-line and will be notified when the system is available (currently scheduled for August 1, 2026. No price adjustments are permitted after art intake.

JUDGES: TBD

AWARDS: Best of Show- \$100; 1st Place - \$75; 2nd Place - \$50; 3rd Place - \$25; Honorable Mention – ribbon

ARTIST PAYMENTS: Payment of the net sale proceeds (sale price less commission) and monetary awards (if any) will be processed, issued, and mailed by the SBPC Treasurer no later than October 25, 2026. The Artist will be provided, along with their check, with a statement including items sold, purchaser and address if available, sale amount, commission, and award (if any). Checks and statements will be mailed to the Artist registration address on file.

DISCLAIMER: Entries will be handled and stored with care; however, the SBPC is not responsible for loss or damage from any cause. The submission of art to the exhibition shall imply an agreement on the part of the artist to the conditions set forth in the prospectus. The Artist consents to the use of his/her name and artwork image(s) for purposes of promotion and advertisement by the SBPC.
